

**EDMONTON OUTDOOR CLUB WAIVER / ASSUMPTION OF RISK AGREEMENT**  
RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

BY COMPLETING THIS DOCUMENT YOU WILLFULLY ACKNOWLEDGE AND UNDERSTAND THE TERMS AND CONDITIONS HEREIN. YOU ARE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE EDMONTON OUTDOOR CLUB, ITS AFFILIATES, REPRESENTATIVES AND MEMBERS.

PLEASE READ THIS CONTRACT CAREFULLY.

**ASSUMPTION OF RISKS:**

I desire my child to participate in the following activity sponsored by the Edmonton Outdoor Club ("EOC"):

---

I understand that in order for the EOC to accept the application for my child to participate in an activity, I must agree to be bound by this Release, Waiver and Assumption of Risk.

I am aware the members of the EOC, acting as trip coordinators of the activities, are not professional leaders, guides, or licensed first aid attendants. I am aware they may not have completed an outdoor leadership course or have first aid (including wilderness) training or experience in either and are not responsible for the safety of my child while participating in this activity.

I am aware that other participants with my child in this activity are not responsible for the safety of my child.

**RELEASE OF LIABILITY WAIVER OF CLAIMS AND INDEMNITY AGREEMENT:**

1 In consideration of being allowed to participate in all phases of activities and events of the EOC, I do hereby waive, release and forever discharge the EOC and its officers, agents, employees, representatives, and all others from any and all responsibilities of liability from injuries or damages resulting from my child's participation in any activities or use of equipment in the above mentioned activities.

2 I understand that EOC outings may be physically and emotionally demanding and may include activities in rugged terrain in all extremes of weather, far from any professional or medical services. I understand that rescues may take more than 24 hours and all medical and rescue costs for my child are my responsibility. I understand that by participating in EOC activities my child may be exposed to real risks of injury, or even death. I understand and am aware that physical activities and the use of equipment are potentially hazardous activities. I understand that equipment may fail and that such failure may cause or contribute to the injury or death of my child. I acknowledge that the leaders cannot foresee all of the risks and hazards associated with participating in EOC activities and agree that this in no way limits the extent or reach of this waiver/release. I hereby agree to assume and accept any and all risks of injury or death of my child, and I forever release the EOC from any responsibility.

3 I agree to assume all risks of personal injury including paralysis and death, that may occur while my child is en-route to and from the activity location and while engaged in EOC activities and events, whether or not under the direct supervision of EOC officers, agents, employees, and representatives. I acknowledge that my child may require transportation to and from the activity location, and agree to assume the risks and responsibilities associated with choosing to provide, or arrange for, my child's own transportation to and/or from the activity location.

4 I acknowledge that the EOC is entirely a volunteer organization and does not carry liability, accident or health insurance of any kind. I understand that it is highly recommended by the EOC that I carry extended health insurance for my child such as Extended Blue Cross in case of injury.

5 I agree that I will not allow my child to engage in any activity unless I have considered it carefully, believe it to be safe, and accept responsibility for all related risks. I acknowledge that my child's safety is my personal responsibility. I agree and warrant that if at any time I, or my child, believe conditions to be unsafe, my child will immediately discontinue further participation in the activity.

6 I understand that fitness and recreation activities involve a risk of injury, heart attack, and even death, and that

my I am allowing my child to voluntarily participate in these activities and use equipment with knowledge of the dangers involved. I do hereby further declare my child to be physically sound and suffering from no condition, impairment, disease, or illness that would prevent his/her participation or use of equipment except as hereinafter stated. I acknowledge that my child has had a physical examination and been given my physician's permission to participate, or that I have decided to allow my child to participate in activity without the approval of my physician and do hereby assume all responsibility for my child's' participation and activities.

7 I fully understand that neither my fellow participants nor any other member or guest of the EOC has any legal obligation to render assistance to my child.

8 I agree to hold harmless and indemnify the EOC, its officers, agents, employees, representatives, and all others from any and all liability for any property damage or personal injury to any third party, resulting from my child's activities and his/her participation in the activities offered by or associated with the EOC.

9 I understand that the EOC, its officers, agents, employees, and representatives shall assume no responsibility or liability for my child for accident, illness, or loss of or damage to personal property resulting from participating in EOC activities and events.

10 I agree that this Release shall be effective and binding upon the undersigned, and my heirs, next of kin, executors, administrators, personal representatives and assigns.

11 By indicating consent for my child's participation in EOC activities, I am acting in good faith and with the full consent of the child's other parent or legal guardian.

**By my signature below I warrant that I:**

Have read and understood the above statements and understand their provisions;

Understand the risks associated with participation in EOC outings;

Assume full responsibility for the consequences of choosing to participate in EOC outings;

Hereby knowingly and intentionally release and hold harmless the EOC, its officers, agents, employees, volunteers, members and representatives from any and all claims, demands, injuries, actions (including third party claims), and damage of any kind and nature whatsoever which arise out of or in connection with my child participating in any and all club activities, trips and outings, regardless of whether such claims are based upon negligence or other grounds.
